The list of Higher Educational Institutions (HEIs) entitled to start full-fledged Online Programmes without prior approval of the UGC, as per provisions stipulated under Regulation 3(B)(a) of the University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendments from academic year 2023-24, academic session beginning February, 2024 and onwards.

- (I) As mandated by the Regulations, online applications were submitted by the Entitled HEIs willing to offer programmes under online mode. Further, each HEI submitted affidavit for ensuring compliance to all the provisions of the University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendments and also deposited prescribed fee as notified by the Commission.
- (II) The duly certified information submitted by the HEI, was to ascertain conformity to the following **four provisions only**:
 1. Entitlement eligibility criteria of the HEI.
 2. Permissibility of proposed programmes to be offered under online mode.
 3. Adherence to UGC Notification of Specification of Degrees, 2014 and its amendments.
 4. Prior approval of Regulatory Authority, wherever applicable.
- (III) Programmes under the ambit of Regulatory Authorities have been considered on the basis of communication/recommendations received from respective Regulatory Authority. The HEIs shall strictly abide by the conditions such as number of seats, recognition period, etc. mentioned in the relevant Regulatory Authority letter.
- (IV) The Regulations also mandate that the Entitled HEIs shall not offer online programmes under any franchise arrangement and shall have complete ownership of these programmes.
- (V) The HEIs are entitled to offer Online programmes, till they are complying NAAC or NIRF ranking requirements as per Regulation 3(B)(a) of University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendments and on non-compliance, they shall discontinue the programmes and accordingly, inform the same to the UGC. The learners already enrolled in the current entitled programmes shall be allowed to complete the programmes in the laid down manner as per the University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendments.

(VI) The List of entitled HEIs which have submitted the affidavit to ensure compliance to University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendments and have been found complying with above mentioned provisions (as per (II) above), for academic year 2023-24, session beginning from February, 2024 and onwards is appended herewith.


(VII) Higher Education Institution shall write UGC entitled as per University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendments' instead of 'UGC recognized' at all places.

(VIII) The Higher Educational Institution shall scrupulously abide by all the terms and conditions as stipulated under Parts III, IV and V of the University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 (including any amendments thereto) and shall take steps as stipulated under Annexure-I to VIII & Annexure-X of the said Regulations.

(IX) UGC decision on last date of admission for offering ODL and Online programmes for academic year 2023-24, academic session beginning February, 2024 and the last date to upload the student admission details on UGC-DEB web portal is as under:

- **Last Date for Admission: 31st March, 2024.**
- **Last Date for Submission of Student Data on the Portal: 15th April, 2024.**

(X) The Higher Educational Institutions have submitted an affidavit to the effect that in case any information, documentary evidence submitted/produced by the Higher Educational Institution is found to be false or wrong at a later stage or in case there is any violation of University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendments by the HEI, the Higher Educational Institution shall be solely liable and responsible for any such contravention/violation and for any consequences thereof (including career consequences of Learner). In such events, the HEI may also be subject to the consequences stipulated under Regulation 7 of University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 (including any amendments thereto).

Sub: Commission Order on the application submitted online by the Higher Educational Institution (HEI) for recognition of the programmes to be offered in Open and Distance Learning (ODL) mode from academic year 2023-24, academic session beginning July-August, 2023 and onwards-regarding.

Sir/Madam,

In exercise of the powers conferred by sub-sections (1) and (2) of section 26 read with clause (j) of section 12 of the University Grants Commission Act, 1956 (3 of 1956), University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 have been notified on 4th September, 2020 in the Gazette of India. Subsequently, the first and second amendments in Principal Regulations have been notified on 01.07.2021 and 18.07.2022 respectively in the Gazette of India.

2. The eligibility criterion for Higher Educational Institution is enumerated under Regulation 3 in Part II of the University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendments. The Regulation 4 and 5 describe the process of application and the approval process for the Open and Distance Learning and Online Programmes whereas Regulation 6 describes provisions of right to appeal by the Higher Educational Institutions aggrieved with the order of the Commission and Regulation 7 describes the process of withdrawal of Recognition.

3. University Grants Commission invited online applications from the eligible Higher Educational Institutions as per Regulation 3(A) and Regulation 3(B)(b) of UGC (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendments for recognition of the programmes under Open and Distance Learning (ODL) mode and/ or Online mode from academic year **2023-24, academic session beginning from July-August, 2023** and onwards vide Public Notice F. No. 1-1/2023 (DEB-I) dated 01st March, 2023, mentioning therein that the online portal for submitting applications shall be open upto 31st March, 2023. However, **Mangalayatan University, Aligarh, Uttar Pradesh** was not able to complete the application process within the stipulated time.

4. Based on the representations received from HEIs for opening the UGC DEB portal for submission of applications for academic session beginning July-August, 2023, Commission in its 571st Meeting held on 25th July, 2023 considered and decided to reopen application window for all such HEIs which had started the application process but could not submit the application due to various issues for academic year **2023-24, academic session beginning from July-August, 2023** and accordingly, HEIs were given 3 days to submit the application on UGC DEB web portal. Further, Commission also decided to curtail the recognition process in respect of these HEIs and no appeal provision shall be applicable to these HEIs. Accordingly, the above Commission decision was informed to the HEI vide letter F.No. 1-1/2023(DEB- I) dated 02.08.2023.

5. Based on Commission decision, UGC DEB web portal was re-opened from 3rd August, 2023 till 5th August, 2023. Accordingly, **Mangalayan University, Aligarh, Uttar Pradesh** submitted its application for recognition of Open and Distance Learning Programmes.

6. As the HEI had applied for the first time since the notification of Regulations, the **Mangalayan University, Uttar Pradesh** was visited virtually by the Visiting Expert Committee (VEC) constituted by the Chairman, UGC on 14th and 16th August, 2023. The report of the Visiting Expert Committee was considered by the Expert Review Committee (ERC) in its meeting held on 23rd August, 2023. However, ERC referred back few under consideration programmes to the VEC. Accordingly, Visiting Expert Committee in its meeting held on 28th August, 2023 re-assessed the under consideration programmes which were referred back by the ERC and submitted its report. The report of the second meeting of the VEC was placed before the ERC in its meeting held on 29th August, 2023.

7. The Expert Review Committee based on the application submitted, compliance to deficiency(ies) or defect(s) communicated earlier, the reports of Visiting Expert Committee and in terms of provisions of University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendments, made recommendations for consideration of the Competent Authority/Commission.

8. Based on the recommendations of Expert Review Committee (ERC) and its approval by the Competent Authority/Commission, I am directed to issue this Order, thereby communicating the programme wise recognition for the programmes to be offered in **Open and Distance Learning mode** from academic year 2023-24, academic session beginning **July -August, 2023** by **Mangalayan University, Aligarh, Uttar Pradesh** as detailed in point no. 9 below. The Expert Review Committee recommendation sheet approved by Competent Authority along with Visiting Expert Committee (VEC) reports have already been communicated to the Higher Educational Institution through UGC-DEB portal on 31.08.2023.

9. Programme wise recognition status

**For Science based programmes, HEI shall ensure that the Intake shall not be more than three times of the approved intake in conventional mode.

***Proposed Master of Business Administration (Marketing, Finance, HR) is recommended for recognition as **Master of Business Administration**.

Note:- (a) The MBA programme (falling under the ambit of AICTE) has been considered on the basis of communication/NOC/approval/recommendations received from the AICTE. The HEI shall strictly abide by the conditions such as nomenclature, valid academic year, period of recognition etc. mentioned in the relevant Regulatory Authority letter, while offering MBA programme in ODL mode.

(b) HEI shall establish a fully dedicated Help Desk for the enrolled ODL students.

(c) Expert Committee directed the HEI to adhere to all the direction/guidelines of UGC and concerned State Government regarding admission procedure.

(d) HEI being a Private University, shall offer programmes under Open and Distance Learning mode from its Head Quarters only: and not through any Learner Support Centre.

(e) HEI shall scrupulously abide by all the terms and conditions regarding faculty and staff requirements for offering ODL programmes as mentioned in Annexure-IV of UGC (ODL Programmes and Online Programmes) Regulations, 2020. HEI shall ensure that the faculty members shown for each programme are on 'full time dedicated basis'.

(f) HEI shall ensure that the delivery of Self Learning Material to learners for ODL programmes is as defined in Annexure-VI and Annexure-VII of UGC (ODL Programmes and Online Programmes) Regulations, 2020.

10. For the programmes recognized in 9(i) above, the Higher Educational Institution shall comply with all the provisions of the University Grants Commission (Open and Distance Learning Programmes and

Online Programmes) Regulations, 2020 and its amendments while offering the programmes in Open and Distance Learning mode. Some specific provisions for compliance have been mentioned in Annexure-1.

11. Based on 571st Commission decision, appeal provision shall not be applicable for the programmes not recognized at point no. 9 (ii) above.

12. Provision stipulated under Sub-Regulation 7 of Regulations 5 of the University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 states that:


"No Higher Educational Institution shall offer any Open and Distance Learning Programme and/or Online Programme and admit learners thereto unless it has been granted recognition by the Commission and admission shall not be made in anticipation of the recognition".

13. In the event of any Higher Educational Institution found offering programmes in Open and Distance Learning mode without recognition of the Commission or in violation to any of the provisions of these regulations and its amendments and guidelines or orders made there under, the Commission may take actions as per Sub Regulation 3 of Regulations 7 in Part-II of University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendments.

14. The application of the HEI for the academic year 2023-24, session beginning July - August. 2023 and onwards **stands closed**.

15. The decision of the Commission shall be final and binding on the Higher Educational Institution.





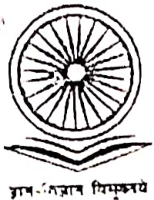

Specific Provisions for Compliance

- 1) The Higher Educational Institution shall comply to all the terms and conditions mentioned in the Affidavit dated 03rd August, 2023 duly notarized and signed by Brig. Sumar Vir Singh, Registrar and Prof. Masood Parveez, Director submitted to the Commission.
- 2) HEI shall abide by the academic calendar as notified by the Commission and upload Student data on UGC DEB web portal within stipulated time.
- 3) Intake capacity of science based programme under Open and Distance Learning mode will be as follows:-
 - For Dual Mode University: Intake shall not be more than three times of the approved intake in conventional mode.
 - For Open University: Learner enrolment shall be commensurate with the capacity of the Learner Support Centres to provide lab facilities to the admitted learners.
- 4) The HEI shall scrupulously abide by all the terms and conditions regarding faculty and staff requirements for offering ODL/Online programmes as mentioned in **Annexure-IV** of University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020. HEI shall ensure that the faculty members shown for each programme are on 'full time dedicated basis' and no faculty member of LSC/other institution is shown as faculty of the HEI.
- 5) The total deployment of work force and other support at study or Learner Support Centres in Open and Distance Learning mode shall be as mentioned in Regulations.
- 6) The HEI shall also adhere to the policy of Territorial Jurisdiction as specified in **Annexure-III** of UGC (ODL Programmes and Online Programmes) Regulations, 2020.
- 7) HEI shall establish "Examination Centre(s)" strictly as per **Annexure-II** of UGC (ODL Programmes and Online Programmes) Regulations, 2020 and conduct proctored examination as under:
 - For ODL Programmes: Examination through pen-paper or online or computer based testing within Territorial Jurisdiction, in the examination centre as per condition laid down in Regulations.
 - For Online Programmes: Examinations either using Computer based test or pen and paper test in a proctored environment in designated test centre with all the security arrangements ensuring transparency and credibility of the examinations. It can also conduct online examination through technology mediated proctoring.
- 8) Programmes under the purview of regulatory authorities have been considered on the basis of NOC/ approval/ recommendation received from the respective regulatory authority. The HEI shall abide by the conditions such as the number of seats, valid academic year, etc. mentioned in the relevant regulatory authority letter.
- 9) HEI offering programmes in Open and Distance Learning mode shall ensure that a Learner Support Centre is established as per Regulations and fulfills following conditions:-
 - Learner Support Centre defined under these regulations shall not be the Learner Support Centre for more than two Higher Educational Institutions at a time to offer programmes in ODL mode.
 - Private University established under the State Act shall be eligible to offer programmes under Open and Distance Learning mode through its Head Quarters; not through any Learner Support Centre.
 - Learner Support Centre will not be set up under a franchisee agreement in any manner.
- 10) HEI offering programme in ODL mode shall prepare Self Learning Material as per **Annexure-VI** and **Annexure-VII** of UGC (ODL Programmes and Online Programmes) Regulations, 2020 taking into consideration the following:
 - At least 60 percent of Self Learning Materials shall be developed by the in-house faculty of the HEI
 - Remaining percent of the materials can be sourced from available resources such as other HEIs, Open Educational Resources (OER) and SWAYAM.

- 11) HEI shall adhere to the weightage for different components of assessments for Open and Distance Learning mode and Online mode as under:
- Continuous or formative assessment (in semester): Maximum 30 percent.
 - Summative assessment (end semester examination or term end examination): Minimum 70 percent.
- 12) HEI shall make mandatory disclosure(s) on its website as per Regulation 9 of UGC (ODL Programmes and Online Programmes) Regulations, 2020.
- 13) HEI shall establish Students Grievances Redressal Committee (SGRC) and appoint Ombudsperson(s) at the Institute or University level as per University Grants Commission (Redressal of Grievances of Students) Regulations, 2023 and as amended from time to time.
- 14) HEI shall establish Centre for Internal Quality Assurance (CIQA) as per **Annexure-I** of UGC (ODL Programmes and Online Programmes) Regulations, 2020 for offering programmes in Open and Distance Learning mode and/or Online mode. HEI shall also submit annual report of CIQA within stipulated time period.




