Subject: Matter related to submission of fixed security deposit in view of issue of Letter of Permission (LOP) Mangalayatan Ayurveda Medical College and Research Center, 33rd Milestone Aligarh-Mathura Highway, PO: Beswan, Aligarh - 202145, establish a new Ayurveda College with 60 seats in UG (BAMS) course from the academic session 2021-22 Under section 29 of NCISM Act 2020 and relevant regulations there under-reg.

With reference to the subject mentioned above, I am directed to inform you that, in pursuance of the provisions of National Commission for Indian System of Medicine Act, 2020, the Indian Medicine Central Council Act, 1970 (48 of 1970) has been repealed with effect from the 11th day of June, 2021 and With effect from the said date, the Central Council of Indian Medicine constituted under sub-section (1) of section 3 of the Indian Medicine Central Council Act, 1970 has been dissolved and as per section 59(2) of the National Commission for Indian System of Medicine Act, 2020 it is stated that, "Notwithstanding the repeal of the Indian Medicine Central Council Act, 1970, the Medical standards, requirements and other provisions of the Indian Medicine Central Council Act, 1970 and the rules and regulations made thereunder shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made thereunder:", The provision of concerned regulations which are inconsistent with the provision of NCISM ACT 2020 shall not be applicable.

Further vide commission's letter of even number dated 07.10.2021, Letter of Intent was issued to your college for the establishment of a new Ayurveda College with 60 seats in UG (BAMS) course from the academic session 2021-22.

However, as per direction of President, Medical Assessment and Rating Board to not to issue letter of permission to Mangalayatan Ayurveda Medical College and Research Center, 33rd Milestone Aligarh-Mathura Highway, PO: Beswan, Aligarh-202145, Uttar Pradesh with 60 seats in BAMS course from the academic session 2021-22 vide letter dated 02.01.2022.

Thereafter, an appeal dated 14.02.2022, has been received in the National Commission for Indian System of medicine act, 2020 against the denial order dated 02.02.2022 of Medical Assessment and Rating Board, which was placed before Chairman, NCISM and Chairman, NCISM constituted a committee comprising members to hear the appeal.

Hence, in view of above and opportunity of hearing was given to college on 25.02.222 and committee recommends to consider the appeal of, Mangalayatan University-Aligarh, Uttar Pradesh and grant letter of permission to start a new Ayurveda Medical College in the name of Mangalayatan, Ayurveda Medical college and research Centre, 33rd Milestone Aligarh-Mathura Highway, PO: Beswan, Aligarh-202145, Uttar Pradesh with 60 seats in BAMS UG in respect of denial order issued by Medical Assessment and Rating Board, NCISM on dated 02.02.2022 for the session 2021-22.

Therefore, as per NCISM Act 2020 and regulation 6 (1) (i) (1) of "Establishment of New Medical College, Opening of New or Higher Course of Study or Training and Increase of Admission Capacity by a Regulations, 2019, you are requested to remit the amount of **Rs. 01 Crore (One Crore)** by way of a demand draft or online payment payable to "**The National Commission Fund for Indian System of Medicine** as fixed security deposit for a period of five years to establish new Ayurveda College with 60 seats in UG (BAMS) course from the academic session 2021-22, Under section 29 of NCISM Act 2020 and relevant regulations there under.
