About the Seminar

“All human beings are born free and equal in Dignity and Rights”

-Article 1, Universal Declaration of Human Rights.

Human rights are the basic which rights belong to every person in the world, from birth till death. These apply regardless of where you are from, what you believe or how you choose to live your life. These should not be taken away, although can sometimes be restricted. These basic rights are based on values like dignity, equality, respect and independence. But human rights are not just abstract concept, these rights are defined and protected by law. Since the adoption of UDHR, global human rights regime has become well established. In addition, discussion on strategies to tackle the human rights issues emerged as a result of development in science and technology. However, the emergence of globalization makes it necessary for revitalizing the strategies and plan of actions for the protection and promotion of human rights. The Universal Declaration of Human Rights, 1948 is a fundamental document for the world. It covered all aspects of the social, economic and political life of human beings. Human rights refer to the fundamental rights of every human being, irrespective of race, sex, religion, political affiliation standing of any other feature.

The preamble and article 38 of the Constitution of India envisages social justice as the arch to ensure life to be meaningful with human dignity. Despite presence of human right laws, it does not necessarily have actual respect of human rights. It depends on the political rights, social conflicts, belief of elites and common citizens. Human rights have become a matter of discussion because of the impact of cultures on people's acceptance and interpretation of these rights. It plays a crucial role in social relation and relations between the state and citizens. Human rights refer to those aspects that uphold the utmost virtues of mankind. Over the past several years, in various parts of our country, it has been seen the rise in infringement of human rights through humanitarian crises.

Human rights violation has become commonplace in some societies in the world, especially in some nations that have been faced with the war. In India, most of the people face so many challenges such as poverty, gender discrimination, corruption, illiteracy, regionalism, unemployment, criminalization of politics, political violence etc. Human trafficking is a heinous issue that is very serious and dangerous for our society. It is widely known that human trafficking has become a growing issue across the world. Human rights are presently a permanent feature of international relations. Human rights are all about the equality and equity of all members of the state. The current economic and political structure greatly affects the achievement of human rights. The political structure is made in
