Both parties hereto, recognizing the benefits of establishing link, wish to strengthen the ties between their respective institution/ industries by entering into this Memorandum of Understanding ("MOU").

NOW IT IS HEREBY AGREED

1. The purpose of the MOU is to develop co-operation and promote mutual understanding and excellence in practice-based education, research, innovation, training and knowledge exchange between the Parties, so that the innovation and knowledge developed is used for regional, national and global well-being of humanity.
2. Both parties agree to join hands and carry out collaborative innovation and training work by or for the student and staff in the following areas:
 - a. Collaborative Management Training
 - b. Inputs for curriculum development
 - c. Work on summer internships and staff training
 - d. Marketing training partnerships and activities
 - e. The outcome could be replicated in other parts of India.
3. Both parties to establish centers of cooperation through mutual agreement.
4. Both will enter into joint training program for student and staff. Thus, both agree in terms of exchange of information and fostering collaboration in training and innovations.
5. The development and implementation of specific activities developed under the MOU will be the subject to formal written agreements negotiated and entered into separately, which will deal with the financial arrangements, confidentiality, ownership and use of intellectual property, publication of articles or the work and relevant matters.
6. It is understood that the implementation of any of the types of co-operation stated in MOU shall depend upon the availability or resources and financial support of the Parties concerned. This MOU will not generate any financial liability or any resource commitment to either party.
7. This MOU may only be amended by a written agreement signed by a duly authorized representative of each Party.
8. This MOU shall commence on the date of its execution by the last Party to sign and shall remain in force for a period of five years. Each Party shall review the status of the MOU at least six months before the end of the five year period to determine whether its wishes the MOU to continue and, if so, whether any modifications are required. The Period of validity of this MOU may only be extended by the mutual written consent of consent of both Parties.
9. Either Party may terminate this MOU by giving six Months' notice in writing to the other. The termination of this MOU shall not affect the implementation of any specific activities established under it prior to such termination.
10. Nothing in this MOU shall be construed as creating any legal relationships between the Parties. The MOU is a statement of intent to foster genuine and mutually beneficial collaboration.
11. In case of any dispute, the dispute may be referred to an arbitrator appointed by mutual consent.
